Under section 39(2) of the Patents Ordinance, to keep the patent in force for a further year after the expiry of the 3rd or any succeeding year from the anniversary of the deemed date of filing of the application for the patent first occurring after the date of grant, the renewal fee shall be paid before the expiry of that 3rd or, as the case may be, succeeding year but not earlier than a date 3 months before that expiry.
